



**NORTHWEST NATIONALS PREMIER SOCCER
PARENT-PLAYER CONTRACT**



This agreement is entered into this ___ day of _____, 200__ by and between _____, a rostered player, hereinafter, ["Player"] on a team organized under the Northwest Nationals Premier Soccer Program, hereinafter ["NWN"] and _____, an authorized parent or guardian of Player, hereinafter collectively ["Parent"] without regard to number gender or form. By entering into this agreement, the Player and Parent agree to abide by the following terms, rules, regulations and guidelines stated hereunder and are subject to the following the sanctions up to and including dismissal from participation of NWN and any of its teams.

1. Each Player and Parent shall be responsible for payment, upon demand, of any or all of the player registration fee as may be established by NWN at the beginning of each seasonal year. A seasonal year is defined by the date of acceptance to play for a NWN team at any time following tryouts and ending of a team's elimination from state cup for the applicable age division as it relates to such player. For purposes of this contract, the seasonal year shall be the 2006-07 year.

A.) Additionally, these terms, rules, regulations and guidelines apply to any Player and or Parent participating on any NWN team as guest player for the purpose of any tournaments or friendlies during the seasonal year. However, said Player and Parent shall only be responsible for their pro-rata share of fees incurred on behalf of that Player/Parent during said participation.

B.) Failure to make payment of any of the required fees at any time as established by NWN will result in the immediate suspension of the Player and Parent from participation with NWN at the sole discretion of NWN.

C) Parent and Player agree that Player's WSYSA card shall not be released until payment is paid in full.

2. Both Player and Parent shall be responsible for payment, upon demand, of any or all of their pro-rata share of any team budget as established by their individual team or as may be amended throughout the seasonal year, including but not limited to the payment of any outstanding fees owing an independent trainer. Parent and Player acknowledge that they have obtained and understand the financial commitment of their individual team's obligations. A team's budget may separate from any additional fees as may be charged by an independent trainer. All uniforms and purchases of new uniforms are the property and right of NWN. Uniforms will be returned to each Team by every Player upon the completion of the season.

A.) Player and Parent further acknowledge and understand that NWN may appoint at anytime during a seasonal year an independent trainer for any team organized under NWN at its sole discretion. Player and Parent shall be individually responsible for payment of all fees associated with an independent trainer.

B.) Failure to make payment of any of the required fees at any time as established by any NWN team will result in the immediate suspension of the Player and Parent from participation with NWN at the sole discretion of NWN.

C) Parent and Player agree that Player's WSYSA card shall not be released until payment is paid in full.

3. Each Player and Parent agrees that they will follow the rules and regulations as established by the Federation of International Football Association, ["FIFA"], the United States Soccer Association, ["USSA"], United States Youth Soccer Association, ["USYSA"], US Club Soccer and Washington State Youth Soccer Association, ["WSYSA"]. In addition to the rules established by FIFA, USSA, USYSA, US Club Soccer and WSYSA, Player and Parent agree to follow any and all conduct rules as established by NWN or as amended.

4. NWN Player/Parent Conduct Rules:

Player and Parent acknowledge and agree that participation with the NWN is a right and that failure to follow any of NWN's Conduct Rules will result in the suspension of the Player and or Parent and can include dismissal from NWN at its sole discretion. These rules are subject to amendment from time to time and it is the player/parents responsibility to ensure they are aware of all rules as amended.

A.) Parent and Player acknowledge and agree that they are participating in the development of a youth select soccer program. That in doing so shall be accountable for the conduct of their actions with other players, coaches, assistant coaches, trainers, team managers, parents, spectators, referees, officers, and any person who by their presence could be construed to have an affiliation with NWN, US Club, WSYSA, USYSA, USSF or FIFA, hereinafter collectively ["Participants"]. Players and Parents agree to maintain professional conduct and respect at all times. Parent and Player agree to ensure that their actions on or off the field do not bring disrespect on any of these Participants.

B.) Parent and Player acknowledge and agree to refrain from making any disparaging, defamatory or critical remarks regarding any Participant in the presence of other Participants. They further agree to refrain from using any demeaning dialogue, abusive language or gestures towards any Participant.

C.) If a Player or a Parent desires to make a comment regarding any Participant, such comments shall be directed to their coach at such a time that will not be distracting or disrespectful to the team or any Participant or otherwise and as discrete as possible. If a Player or Parent has a comment regarding the conduct of a coach which cannot be handled directly, Player or Parent should contact the then appointed coaching director of NWN for resolution. If the matter involves the coaching director, Player or Parent is advised to contact the then acting President of NWN. If the matter involves any officer of NWN, Player or Parent should submit such comments to a member of the Board of Directors.

D.) NWN has adopted a zero-tolerance for any illegal activities involving alcohol, non-prescribed drugs or weapons, regardless of circumstances. No Player will attend any function that involves minor consumption by minors of alcohol or drugs.

E.) Out-of-town tournaments: NWN teams will travel and lodge together, unless special permission is given by the teams coach. Small group activities must be approved by the head coach. Players will wear team elected attire. Players are not allowed outside of hotel rooms after "lights out" without explicit permission from the designated chaperone. Attendance at all team functions, including practices and meetings is mandatory.

Sanctions:

Any violations of the Player/Parent Conduct rules will result in any of the following at the sole discretion of NWN:

- i) Suspension from participation of any or all NWN activities, practices and games for an undermined period of time, but in no event longer than 30 days.
- ii) Dismissal from any further participation with, including removal and release of the Player and/or Parent or both from NWN participation.
- iii) Parent acknowledges and agrees that any sanction imposed by a member of NWN against any Parent may be oral or in writing.
- iv) Issues involving Player misconduct of the Player Conduct Rules resulting in the suspension of a Player will be in writing and given to the individual Player's parent. The writing will describe the misconduct in violations of the Player Conduct Rules and the amount of time the Player will be suspended. The suspension of a player for misconduct is at the sole discretion of the coach or NWN. Sanctions involving the removal and a release of a player from NWN will be reviewed by the Coaching Director for compliance with Player Conduct Code. If the removal and release was instigated by the Coaching Director, compliance will be reviewed by the Board of Directors.

5. All Players will maintain academic standards and guidelines as established by the individual head coach. A player may be suspended from play indefinitely until such time Player brings their grades in compliance or makes arrangements for supplemental educational support. Player agrees to provide their individual coach with their academic standing upon request.

6. Parents authorize NWN the use of Player's photograph or other likeness for the purpose of promotion of NWN, individual teams or Player. Parent further agrees to allow the use of Player's personal information by NWN for Player promotion. Parent waives and releases liability to NWN and any of its affiliates for any actions that may arise out of use of Player Promotion. NWN agrees to use Player's personal information for the sole purpose of Player Promotion only.
